Solicitor Weiler informed Mr. Templin to do a roll call vote for each nominee. The roll call vote for Mr. McCauley was Mr. Happel, Mr. McCauley and Mr. Blank voted yes. Mr. Lusky, Ms. McKinney and Mr. Templin voted no. The roll call vote for Mr. Lusky was Mr. Lusky Mr. Templin and Ms. McKinney voted yes. Mr. Blank, Mr. Happel and Mr. McCauley voted no. Due to a tie, Solicitor Weiler informed President Templin the mayor must break the tie. Mayor Myers voted for Mr. McCauley for Vice President

Upon motion made by Mr. McCauley and seconded by Mr. Blank, nominations were unanimously closed and Mr. McCauley was elected as Council Vice-President.
